

PROTECTING CHILDREN



Shelter, Inc. has two homes in Chicago's northwest suburbs that provide youth, aged 11-17, with emergency **shelter**, **security, and healing** while experiencing crisis due to abuse, neglect, homelessness, and more. The homes are in established neighborhoods and staffed with caring professionals who provide trauma-informed care 24 hours a day, 365 days a year.

Foster Care

116 CLIENTS 19,000 DAYS OF CARE 22 PERMANENCIES ACHIEVED

Shelter, Inc.'s Foster Care programs for children, from birth through 21 years, include home-of-relative, traditional, and emergency foster care. In many cases, children are placed in foster care because they have been abused or neglected and are unable to continue living safely with their families. Sometimes homelessness, loss of income, addiction, hospitalization, mental illness, or parental death make it impossible for a biological family to care for a child. These children all need **safety, love, support,** and **guidance**. Our Foster Care caseworkers work with families to resolve problems so children can be reunited as quickly as possible.

NEW HOME FOR YOUTH SURVIVORS OF HUMAN TRAFFICKING



Shelter, Inc., in partnership with Housing Opportunity and Development Corporation (HODC) and SI Container Build, will open **Illinois' first DCFS-licensed home for female youth survivors of human trafficking**. To support this program and its survivors, we successfully secured funding to purchase land and a \$5 million grant from DCFS to build a 12-bedroom home in Palatine, IL. Shelter's professional staff will provide 24-hour **t**rauma-informed care and comprehensive services to help survivors build the skills, strength, and self-esteem they need to develop to their full potential. We are **deeply grateful to our funding partners: Foglia Family Foundation, Canning Foundation. Fitzgerald Family Foundation, The Chicago Bears, and Endeavor Health Community Investment Fund.**

STRENGTHENING FAMILIES



Shelter, Inc.'s **Healthy Families Program** is a nationally recognized home visiting program that offers five years of free, one-on-one support for first-time parents who face multiple challenges. Our staff work with parents during a child's most formative years helping parents create an environment where their children can be secure, nurtured, and thrive. Home visiting services break cycles of crisis and strengthen families.

Clinical Care


53 CLIENTS 370 HOURS OF CARE



Crisis, instability, and abuse have a detrimental long-term impact on families and young people. By providing quality **Clinical Care** for emotional healing and recovery, we can equip families and young people with the skills and tools they need for a brighter future. Our Clinical program breaks down barriers to receiving quality mental health care by increasing access and coordinating care.

A Behavioral Health Expansion Initiative Grant from the Cook County Department of Public Health is enabling us to expand our mental health services to underserved areas of Cook County.

TRANSFORMING COMMUNITIES



Shelter's **Transitional Living Program (TLP)** is a two-year, voluntary program for young people, ages 17-21, assigned male at birth who will soon age out of the child welfare system. These young people often arrive at TLP lacking the basic life skills we take for granted, like how to budget finances, apply for a job, grocery shop or even do laundry. Programming and support ensure each resident achieves self-sufficiency and independence.

Youth Experiencing Homelessness Program

6 YOUTH SERVED 758 DAYS OF CARE



Some youth have left difficult home situations and need shelter beyond the temporary kindness of friends or the danger and instability of living on the streets. Shelter's Youth Experiencing Homelessness Program helps young people find the **housing** and **resources** they need to ensure their **safety**, improve their well-being, and help them become self-sufficient



This past year, Executive Director, Carina H. Santa Maria, was appointed to the Illinois Foster Care Council, the Cook County Child Death Review Board, and the Child Policy Board, giving Shelter an opportunity to **shape Illinois child welfare policy**. In addition, staff shared experience and expertise with local educators, social service workers, law enforcement, and more to advocate for at-risk youth.
